- **12. Pricing and Payment**

- **13. Cancellation By You**

13.2 To cancel your *Order* you must notify us in writing, including email. We will refund the cost of the items you wish to return within 14 days of your cancellation.

13.3 The items you wish to return must be received by us within 14 days of your cancellation in a condition suitable for re-sale.

13.4 Expect where items are faulty, we retain the option to reclaim the costs of recovering returned item.

- **14. Cancellation by Us**

14.1 We reserve the right to cancel the *Contract* if:

a. *Conyers Guns* have insufficient stock to deliver the Goods you have ordered

- b. *Conyers Guns* do not deliver to your area or country
- c. One or more of the *Goods* you ordered was listed with incorrect product information.

- - **15. Disclosure to Government Bodies**
